Registration and Logistics

1. Decide which ETA certification(s) you would like to take and review the free objectives/competencies provided by ETA. Additional study materials may be available other than the ones listed previously.
2. Find an ETA certification administrator (CA) close to you to proctor the exam. You can search ETA's online database of test sites at www.etai.org/test_sites.html, or contact ETA at (800) 288-3824.
3. The APX® Radio Technician exam is available in test booklet form to be taken immediately after **RDS1023 APX SUBSCRIBER TRAINING WORKSHOP**. Note: A certification administrator must be present.
4. Arrange a time to take the exam with the chosen certification administrator.
5. Arrive early with the proper materials to take the exam. You may bring scratch paper and a non-programmable calculator to the exam. For the APX® Radio Technician exam, you will be given two hours if needed. Photo ID is required. No other electronic devices are permitted.
6. Once completed, the certification administrator will submit your exam and information along with payment. Testing online with ETA's **TRAPEZA system**, you will be able to view your score(s) immediately.
7. Examinations are processed within 7-10 business days of arrival at ETA headquarters. However, scores may be requested online through the ETA website (www.etai.org/exam_results.html) or contact ETA at (800) 288-3824.

How do I find out my score?

If you take your exam online with ETA's **TRAPEZA system**, your results will display immediately after completing the test. Do not click the NEXT button too quickly after your SUBMIT button; **have patience while the system tabulates**. If you test either online or on paper ETA will process and mail your exam results and certification materials to you within 10-15 business days.

What if I have other relevant industry-recognized certifications or completed related training?

Motorola Solutions understands that some individuals may already be competent in the requirements for obtaining this certification. The APX Subscriber and Tools Certification requires that an individual complete RDS1023 APX SUBSCRIBER TRAINING and provide written evidence of having attended prior to attempting the exam.

How long will my APX Radio Technician certification be valid?

Your ETA APX Subscriber and Tools Certification is an indefinite certification, recertification is not required.
